

VENDOR AGREEMENT

Vendors may arrive no earlier than 3:00pm and must be in their space by 4:55pm. Vendors not in their assigned space by 4:55pm on market day forfeit the space. No refunds will be given.

Resale of spaces is not allowed. Junior Foundation will not honor any vendor-to-vendor sale of spaces or allowances.

Vendors understand that once a space is paid for, no refunds, no rain checks, no exchanges will be honored.

Sales end at 10:15pm All vendors must vacate the campus by 10:45pm. Vendors not cleaned and off campus by 10:45pm are subject to a \$20 fine.

Vendors must remain present throughout the duration of the event. Vendors shall be selling until at least 9:45pm. Early exit is not permitted.

Sellers are required to keep their booth area and the area directly in front of their booth clean. When leaving, your space MUST be clean and in the same condition as when you arrived or you may be banned from further events.

Violators are subject to a \$20 cleanup fine. Trash, boxes, or other debris may not be left on the grounds.

Vendors shall keep all merchandise, display units, coverings, and any and all possessions within the boundaries of their assigned space.

In case of rain, no credits or refunds shall be issued to vendors.

Excessive noises (such as stereos, radios, televisions, shouting, amplified voices) will not be allowed. Music can be played with discretion.

Any vendor caught selling stolen, counterfeit, black market, illegal merchandise of any kind or any food or beverages is subject to having said merchandise confiscated at the event, may face arrest by local authorities, immediate eviction from the event and loss of selling privileges without a refund.

Consumption or possession of alcoholic beverages and all controlled substances is forbidden. Smoking is prohibited anywhere on campus.

Canopies must have 20lb weights tied to each leg. Each leg of the canopy shall have a weight attached and/or be tied to your vehicle. Tying to the solar panel legs, building posts or any fixture of the campus is not permitted.

Vendors selling nonpackaged food must have an enclosed booth with walls.

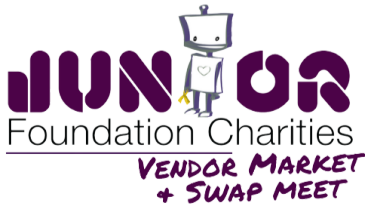

ACUERDO DE VENDEDORES

Vendedores no pueden llegar antes de las 3:00pm y deben estar en su espacio para más tardar las 4:55pm. Vendedores que no estén en su lugar asignado para las 4:55pm pierden su lugar. No se les dará reembolsos.

No se permite vender su espacio. Junior Foundation no aceptará la venta de espacio entre vendedores.

Vendedores entienden que en cuanto pagan por su espacio no tienen derecho a reembolsos, créditos de lluvia, cambios o cancelación con reembolso.

Las ventas terminan a las 10:15pm. Todos los vendedores deben estar fuera de la escuela a las 10:45pm más tardar. Vendedores que no han limpiado y salido para las 10:45pm serán multados \$20.

Vendedores deben permanecer presentes durante todo el evento: 4pm-10pm y deben estar vendiendo hasta las 9:45pm. No se permite salir temprano.

Debe tener su área y el área directamente en frente de su espacio limpio. Al momento de salir, su espacio debe estar limpio y en la misma condición que estaba cuando llegó. Si no está, será bloqueado de futuras reservaciones y/o multado \$20.

Si usa carpa, debe tener pesas de 20lbs. en cada pie de la carpa. Cada pie de la carpa debe llevar su pesa y/o estar amarrada a su carro. No se permite amarrar la carpa o cualquier artículo a los paneles solares ni cualquier poste o parte de la escuela.

Vendedores de comida que no esté empaquetada deben tener una carpa con paredes que cubra su puesto.

Basura, cajas y otros artículos no pueden ser dejados en su espacio. Los que dejen basura serán multados \$20 y/o se les bloqueará las reservaciones.

Vendedores deben dejar toda su mercancía, displays, carpas y todas sus posesiones y artículos dentro de su espacio asignado.

En caso de lluvia, no se darán créditos ni reembolsos.

Ruido excesivo no es permitido. Música es permitida con discreción.

Vendedores que venden artículos robados, falsos, de la marketa negra, mercancía ilegal o comida o bebidas están sujetos a que la mercancía sea confiscada en el evento, podría tener problemas con las autoridades locales y ser expulsados del evento con pérdida de derechos de ventas y sin reembolso.

No se permite el consumo ni la posesión de bebidas alcohólicas, drogas o cualquier sustancia controlada. No se permite fumar en toda la escuela.

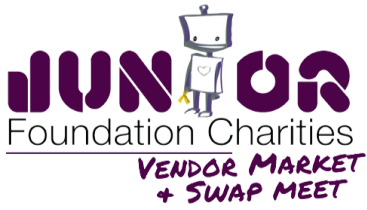

Sales of the following items are not permitted:

The sale of any ingestible goods, including but not limited to food products, beverages, water, and pharmaceuticals without the prior written consent of Junir Foundation Charities and a current Health Permit issued by The San Bernardino County Health Department.

Alcohol, Tobacco, Vape items, drugs are not allowed to be sold or used on the premises.

Pets or live animals of any sort

Sale nor use of Riding bicycles, skates, skateboards, or scooters on the premises, without prior agreement.

Merchandise bearing counterfeit trademarks or merchandise that infringes on copyrighted designs or materials.

Firearms, ammunition, flammables, explosives, fireworks, weapons of any kind, or other dangerous items.

Knives or weaponry, mace-like products, pepper spray, and any other harmful items.

Pornographic or adult-themed merchandise.

Drug-related paraphernalia.

Games of chance, raffles, or lotteries.

Fortune telling, palm reading, biorhythms, spiritual counseling, handwriting analysis.

Excessive noise, such as loud music, shouting, or music with inappropriate lyrics.

Stolen merchandise.

Items that by sale, possession, or use are in violation of City, County, State, or Federal Laws.

Illegal products not normally obtained on the open market.

Due to the family atmosphere of the event, the management reserves the right to reasonably restrict the sale or display of any items in order to maintain a proper moral and wholesome environment.
